



## ***TAGCO MET RETIREE MEDICAL COMMISSION AGREEMENT***

### ***Agent***

This TAGCO Multiple Employer Trust Retiree Medical Commission Agreement pertains to *group* Retiree Medical insurance written by TAGCO Associates, LP's Agent.

Such *group* Retiree Medical insurance will be underwritten and fully insured by Hartford Life & Accident Insurance Company and issued by the TAGCO Multiple Employer Trust (TAGCO MET), on behalf of The Hartford. Further, such *group* Retiree Medical Insurance Program will be administered by Group Administrative Concepts, Inc. (GAC), on behalf of The Hartford, TAGCO Associates, LP and the TAGCO MET.

GAC will bill and collect such *group* Retiree Medical insurance premiums on a monthly basis and will pay TAGCO Associates, LP's Agent on a monthly basis—based on net commissionable premium received, as billed in the previous month. Such commissions are expected to be paid around the middle of each month.

GAC will pay such aforementioned Agent a monthly commission of five (5) percent of net premiums received.

Agent—five (5) percent of monthly premium received;

For clarification purposes, commissionable premium shall be established by the rate at which TAGCO MET *group* Retiree Medical Insurance Program employers and/or retirees are billed—less a monthly non commissionable rate of \$10 PMPM (Per Member Per Month) charged by The Hartford, for internal administration charges related to claims and eligibility administration.

Such commission paid by GAC, on behalf of The Hartford, TAGCO Associates, LP and the TAGCO MET, will be paid on a *first and renewal* basis for as long as such TAGCO MET Retiree Medical Insurance Program is underwritten by Hartford Life and Accident Insurance Company and issued via the TAGCO Multiple Employer Trust or until The Hartford notifies TAGCO Associates, LP in writing, of material changes to current TAGCO MET plans offered by TAGCO Associates, LP.

***TAGCO MET RETIREE MEDICAL COMMISSION AGREEMENT (CONTINUED)***

For clarification purposes, *first and renewal* shall mean that commissions will be paid to the appropriate licensed and appointed person or agency, for as long as such TAGCO MET *group* Retiree Medical Program remains in force. Further, such *first and renewal* commissions shall include any Medicare trend and/or TAGCO MET rate increases, as determined by The Hartford's TAGCO MET Senior Underwriter.
